GENERAL: This pre-offer real estate Review, Evaluation and Consultation is offered to assist the home buyer in determining whether an offer should be made on a real estate property. ***Due to the limitations of time and resources that are consistent with a pre-offer home consultation, Haus Inspection Services will not be responsible for any deficiencies discovered later in the home.*** This review, evaluation and consultation will consist of some observations of the most critical components of the home but is not as comprehensive or thorough as a pre-purchase home inspection. This review does not meet the standards of a full home inspection and is not a pest or wood-destroying organism inspection. **There will be no written report or review**, but a verbal recap will be offered at the end of the consultation. ***It is highly recommended that a complete home inspection be completed if the offer to purchase the property in question is successful.***

PROPERTY REQUIREMENTS: The building, its components and equipment are to be ready and accessible at the time of the review, evaluation and consultation. All utilities and pilot lights must be on and all equipment operational, and **access to all areas of the structure, including the heating system, water heater, electrical panel, crawl space and the attic areas, if applicable, roof and gutters are to be clean and free of obstructions** so that a visual review can be completed on that date. This is the responsibility of the client. The inspector is not obligated to change light bulbs, light pilot lights, move furniture, stored belongings, obstructions, or floor coverings, or remove panels to inspect any part of the building or its equipment. Client acknowledges that this consultation can only be performed on homes where no mutual acceptance of an offer to purchase the home exists and that the inspector is unable to verify if the seller has accepted an offer from a seller. **THE FEE FOR THIS SERVICE IS DUE AT THE TIME OF THE CONSULTATION.**
